The aim of the symposium is to focus on the intersections of Gender, Class and Culture in the 21<sup>st</sup> century, with a specific focus on connecting comparisons between China and the Nordic countries. The workshop will focus on new and old forms of social and gender inequalities, identities and structures as well as new forms of gendered subjectivities in the context of globalization, neoliberal reforms and ways of life, in East and West. Special focus will be on 'globalization' from below and how global and local forces are effecting new forms collective cultures, ideas and categories and forming multiple ideas of masculinity and femininity.

The symposium aims at presenting themes on legal and social activism, related to body, health, welfare and environment. And also, to focus on new ways of doing middle class, new lifestyles and everyday life in the home, family, parenting, child care, and educational practices.

**Format:** The symposium will have participants from Denmark and Nordic countries and from China. The speakers and participants are faculty members and Ph.D.-fellows from University of Copenhagen and other Nordic universities, and from a range of Chinese universities and research institutions. A limited number of faculty members, Ph.D.-fellows and MA students from the Shanghai area will be invited as participants without papers. The maximum number of participating scholars will be 25-30.

The goal is to work towards setting up research networks and educational cooperation, and to launch book proposals centered on connecting comparisons between China and the Nordic countries, in new and cutting edge thematic areas related to gender, class and culture.
